### **Nokotsudo Agreement**

The family or responsible party or parties requesting inurnment of an Urn in the Nokotsudo of the Tri/State Denver Buddhist Temple (Temple) agree(s) to the Rules and Regulation and those definitions and terms on Appendix A of this Agreement, of use as administered by Nokotsudo Committee (“Committee”), established by the Board of Directors (Board) of the Temple.

1. It is understood and agreed that the provisions of this Nokotsudo Agreement shall be subject to the policies, rules and regulations of TS/DBT, as modified and amended from time to time, and shall apply to and bind the heirs, executors, administrators, and assigns of those persons identified below. Any and all notices will be mailed to the physical address and or emailed to the email address identified below.
2. Continuing inurnment of cremains will be subject to current and future Temple policies, rules and regulation regarding inurnment and visitation of the Nokotsudo.
3. Opening and closing of the Nokotsudo and niche(s) will be done by Temple staff only. Visitation to the Nokotsudo will be during the regular office hours of the Temple or by special arrangements. The right at any time to move or relocate any inurned urn at any time is expressly reserved to Temple Ministers, staff and volunteers.
4. Emplacement of urn(s) shall be situated in TS/DBT existing Nokotsudo until such time as the expanded Nokotsudo renovation is completed. The selection of individual niche location within the expanded Nokotsudo will be dictated by date of Emplacement and or Purchase Reservation of niche(s) in chronological and processed order.
5. The dimension of the individual niche is 10.5” (H) X 10.5” (W) X 11” (D), and may have a minimal variance due to architectural design of the whole area. During the expansion and renovation of the Nokotsudo area the initial 200 individual niche purchases shall be priced at \$2,500.00, and until June 2015. The maximum size urn placed in individual niches is 10” (H) X 8” (W) X 10” (D).
